## **State of Maine** **Utility | Farm | Personal Use Trailer Registration Packet**

(This packet only needs to be filled out the first time you register something with us.)

In an effort to make this as simple and hassle free as possible, we have assembled this packet which outlines all of the information required for us to register your trailer(s) in the state of Maine.

- **What's included in this packet?**
  1. **Owner Information Sheet:** (Page 2)
    - a. It is very important that all information be filled out completely. We will need **Date of Birth** (for individual) or **Federal ID #** (for company).
  2. **Power of Attorney:** (Page 3)
    - a. This Sheet must be notarized by a notary, and returned with your paperwork.
  3. **Services Offered** (Page 4)
  4. **Credit Card Form** (Page 5)
- **Accepted Forms of Payment:**
  - ✓ **Credit Cards** (*MC, Visa, Discover and American Express*)
  - ✓ **Money Orders** (made payable to Haskell Registration)
  - ✓ **Business Checks** (made payable to Haskell Registration)

**As of January 1<sup>st</sup>, 2017 we no longer register: Camper Trailers, Pop-Up Campers, RV's or Bunkhouses.**

### **SALES TAX:**

Out-of-state residents desiring to register a trailer in Maine must pay sales tax unless you can prove you have paid an equivalent amount (5.5%) somewhere else. If you paid less than our tax, you will pay the difference. If you can prove the trailer was registered by you in another state, you will owe no sales tax. (*Proof should consist of a copy of a registration in your name or bill of sale reflecting the sales tax paid.*) Commercial **semi-trailers** (pulled by a tractor) are exempt from sales tax.

### **TITLE: (\$58.00)**

If your trailer is **1994 or older OR less than 3001 pounds (empty weight)** it CANNOT be titled in Maine, but CAN still be registered. All we require is:

1. A copy of your proof of ownership (bill of sale, previous registration or title signed over to you from another state)

If the trailer is **1995 or newer AND weighs 3001 or more pounds (empty weight)** you will need to include:

1. Photocopy of a title that is in your name and on the front of your title.
2. If it has NOT been titled in your name already you will need to mail us your ORIGINAL Manufacture's Certificate of Origin or TITLE so we can get a Maine title for you.

**IMPORTANT NOTICE:** *Although it is legal, in the State of Maine, to provide a valid Maine Plate and Registration to an out of state registrant, it may NOT be legal for you to register your trailer outside the state in which you reside. We would advise you to check with your local municipality or law enforcement to make sure that you are abiding by your current State Laws. If you choose to ignore your state laws, you do so at your own risk.*
