## **State of Maine** **Concession & Game Trailer Registration Packet**

Dear Valued Client:

In an effort to make this as hassle free as possible we have assembled this packet which outlines all of the information required for us to register your trailer in the state of Maine. We have also included for your use all of the required forms that will be needed for HASKELL REGISTRATION to get your process started.

1. **Owner Information Sheet: (Page 2 of this packet)**
  - a. It is very important that all information be filled out, in order for Haskell Registration to process your registration. We will need **Date of Birth** (for individual) or **Federal ID #** (for company).
2. **Power Of Attorney Sheet: (Page 3 of this packet)**
  - a. This Sheet must be notarized by a notary, and returned with your paper work.
3. **Payment: (Page 5 can be used to assist in payment process if desired.)**
  - a. At Haskell Registration we provide fast and reliable service, but in order for us to do that we do require payment up **front** and **in full**.

- A. Money Orders (**Made payable to Haskell Registration**)
- B. Credit Cards (**MC, Visa, Discover and American Express**), see attached credit card sheet.

### **Proof of Ownership required in order for us to register your “Concession Trailer”:**

1. A copy of a title signed over to you – or – A Bill of Sale.
2. A Title or Registration already in your name.

### **Please be advised:**

- You do NOT pay sales tax on Concession or Game Trailers.
- Concession & Game Trailers CANNOT be titled in the state of Maine.
- Concession & Game Trailers CANNOT have long-term plates, and they must be registered annually or bi-annually.

**IMPORTANT NOTICE:** *Although it is legal, in the State of Maine, to provide a valid Maine Plate and Registration to an out of state registrant, it may NOT be legal for you to register your trailer outside the state in which you reside. We would advise you to check with your local municipality or law enforcement to make sure that you are abiding by your current State Laws. If you choose to ignore your state laws, you do so at your own risk.*
