State of Maine Trailer Registration

Dear Valued Client:

In an effort to make this as hassle free as possible we have assembled this packet which outlines all of the information required for us to register your trailer in the state of Maine. We have also included for your use all of the required forms that will be needed for HASKELL REGISTRATION to get your process started.

1. **Owner Information Sheet: (Page 2 of this packet)**
 - a. It is very important that all information be filled out, in order for Haskell Registration to process your registration. We will need **Date of Birth** (for individual) or **Federal ID #** (for company).
2. **Power Of Attorney Sheet: (Page 3 of this packet)**
 - a. This Sheet must be notarized by a notary, and returned with your paper work.
3. **Payment: (Page 5 can be used to assist in payment process if desired.)**
 - a. At Haskell Registration we provide fast and reliable service, but in order for us to do that we do require payment up **front** and **in full**.

Methods of payment are as follows:

- A. Money Orders (**Made payable to Haskell Registration**)
- B. Credit Cards (**MC, Visa, Discover and American Express**), see attached credit card sheet.

As of January 1st, 2017 we no longer register: Camper Trailers, Pop-Up Campers, RV's or Bunkhouses.

SALES TAX:

Commercial **semi-trailers** (pulled by a tractor) are exempt from sales tax.

TITLE: (\$58.00)

If your trailer is **older than 1995 or less than 3001 pounds (empty weight)** it CANNOT be titled in Maine. All we require is:

1. A copy of your proof of ownership (bill of sale, title or previous registration signed over to you from another state)

If the trailer is **1995 or newer and weighs over 3000 pounds (empty weight)** you will need to include:

1. Photocopy of a title that is in your name and on the front of your title.
2. If it has NOT been titled in your name already you will need to mail us your ORIGINAL MCO (Manufacture's Certificate of Origin) or TITLE that has been signed over to you on the back so we can obtain a Maine title for you.

IMPORTANT NOTICE: *Although it is legal, in the State of Maine, to provide a valid Maine Plate and Registration to an out of state registrant, it may NOT be legal for you to register your trailer outside the state in which you reside. We would advise you to check with your local municipality or law enforcement to make sure that you are abiding by your current State Laws. If you choose to ignore your state laws, you do so at your own risk.*
