B. If you have NOT registered your trailer before, we will need a copy of your Bill of Sale or Invoice. (Must include VIN, year, make, sale price, and be signed by the seller over to you or your business).

- i. Maine does NOT charge sales tax on these types of trailers.
- C. OR a copy of a Title that has been signed over to you or in your name.

  i. Maine does NOT title Amusement, Concession, Food, Game, or Special Equipment Trailers.
- D. We cannot register or title Salvage Titles.



**NOTE:** Please contact us before you complete this form if you are trying to register a Homemade Trailer.



# IMPORTANT NOTICE



Although it is legal, in the State of Maine, to provide a valid Maine Plate and Registration to an out of state registrant, it may **NOT** be legal for you to register your trailer outside the state in which you reside.
