### **4 BILL OF SALE, INVOICE, OR COPY OF REGISTRATION**

A. If you have previously registered the trailer(s) in your name, we will **ONLY** need a **COPY** of your Registration or Renewal Notice.

*i. You may proceed to page 2 if this applies to your trailer.*

B. If you have **NOT** registered your trailer before, we will need a copy of your Bill of Sale or Invoice. (Must include VIN, year, make, sale price, and be signed by the seller over to you or your business).

*i. Maine's Sales Tax (5.5%) may apply, if not paid already.*

*ii. **Read below to see if you are REQUIRED to title as well.***

C. We cannot register or title Salvage Titles.



### **5 THE ORIGINAL TITLE OR CERTIFICATE OF ORIGIN**

**1.** Your trailer is 25 years old or newer.

**2.** AND your trailer weighs 3,001 LBS or MORE UNLOADED weight and has not been titled in your name previously.

**If the title is already in your name, Haskell Registrations will need a copy of it.**

A. Trailers that are 3,000 lbs. or less UNLOADED weight cannot be titled in Maine but can be registered here with just a Bill of Sale.

B. If you wish to get a title in your name, we advise you to do a **"Title ONLY"** in your state and pay your sales tax **BEFORE** you register your trailer in Maine and provide us with a copy of the receipt.



**NOTE:** Please contact Haskell Registrations before you complete this form if you are trying to register a Homemade Trailer.

*As of January 1st, 2017, we no longer register: Camper Trailers, Pop-Up Campers, RV's or Bunkhouses.*
